APPLICATION FOR REFERENDUM APPROVAL

TO ALL QUALIFIED VOTERS ENTITLED TO BE ENTERED ON THE REFERENDUM LIST FOR THE AREA CONSISTING OF ZONES RU-4, VI-2, VI-3, VI-5, VID-1, RU-3 AND RU-9 OF THE MUNICIPALITY OF THE TOWNSHIP OF GORE

PUBLIC NOTICE is given of the following:

A public consultation was held on September 15, 2025, at 8 p.m. on the first draft resolution (2025-09-192) regarding the Specific Construction, Alteration or Occupancy Project of an Immovable (SCAOPI) has been submitted to authorize, on a specific and exceptional basis, the addition of the use "Indoor Recreation and Entertainment Business (C5)" on lots 5 080 562 and 5 082 612, located at 7 Kerr Road, in zone RU-4. Following this public consultation, the Municipal Council adopted, at the regular meeting of October 1, 2025, the second draft resolution concerning the same project (resolution 2025-10-226).

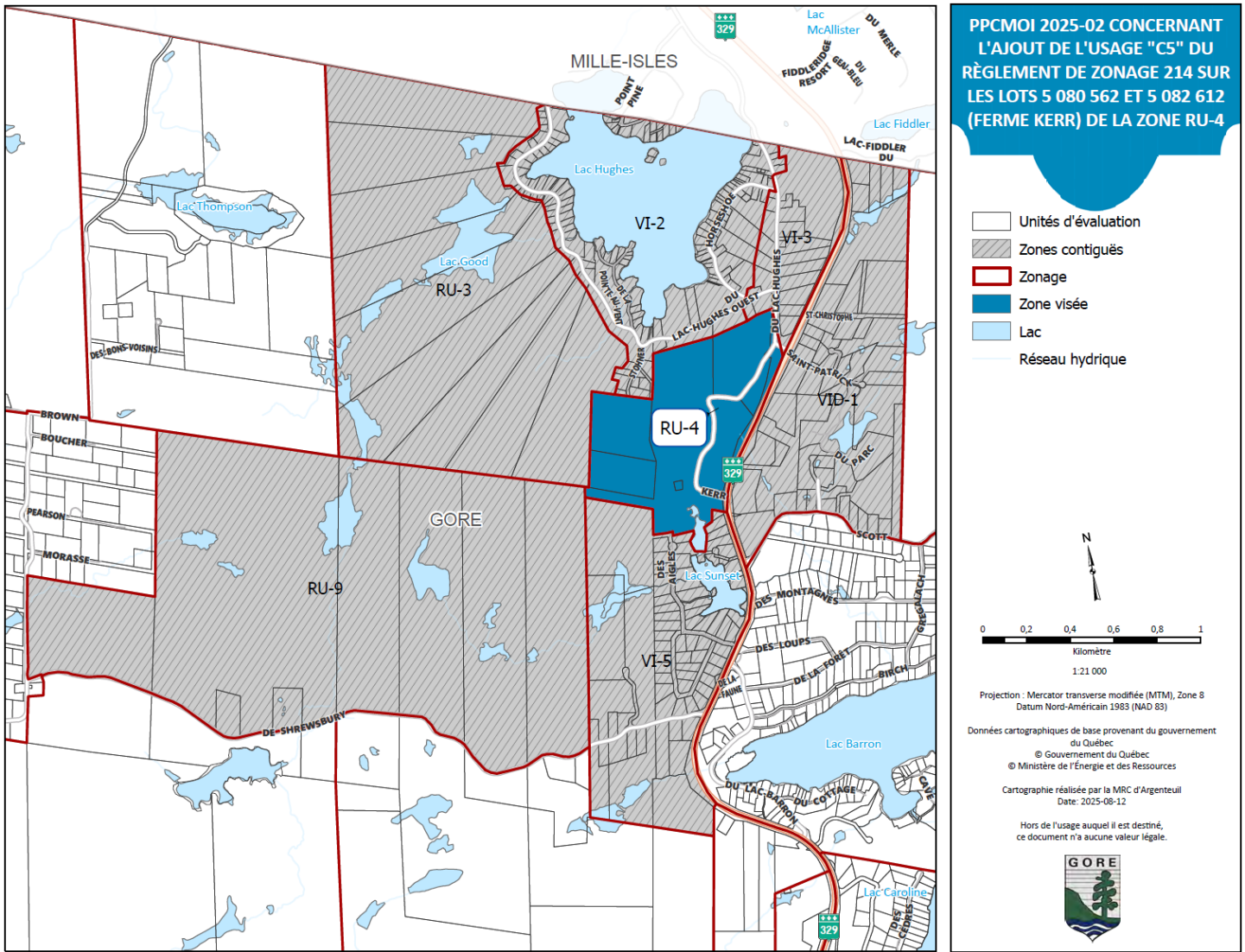
This second draft was adopted without amendments.

APPLICATION FOR REFERENDUM APPROVAL

This second draft resolution contains provisions that may be the subject of a request by interested persons in the RU-4 zone (the affected zone), and the contiguous zones VI-2, VI-3, VI-5, VID-1, RU-3 and RU-9 for their approval in accordance with the Act respecting elections and referendums in municipalities, for the provision of the second draft resolution of this PPCMOI as follows:

Addition of the use of "indoor recreation and entertainment business (C5)" to lots 5 080 562 and 5 082 612, located at 7 Kerr Road and commonly referred to as "Kerr Farm".

Interested persons may file an application to submit the resolution for approval by the qualified voters in the zone to which it applies and in any contiguous zone from which a valid application originates.

**CONDITION FOR THE VALIDITY OF AN APPLICATION**

To be valid, any request must:

- Clearly indicate the provision to which the request relates and the zone from which it originates;
- Be signed by at least 12 interested persons from the zone from which it originates or by at least the majority of them if the number of interested persons in the zone is 21 or less;
- Be received by the municipality, at the office located at 9 Cambria Road in Gore, no later than the 8<sup>th</sup> day following the publication of this notice.

**CONDITIONS REQUIRED IN ORDER TO HAVE THE RIGHT TO SIGN A REQUEST:**

**IS** a qualified voter:

1. Any person who, on October 1, 2025, is not under any disqualification to vote as provided for in section 524 of the *Act respecting elections and referendums in municipalities* (R.L.R.Q., c. E -2.2) and who meets the following conditions:
  - Be a natural person domiciled in the area from which a request may originate;
  - Be domiciled in Quebec for at least 6 months.
2. Any owner of a building or occupant of a business establishment who meets the following conditions on October 1, 2025:
  - Be the owner of a building or occupant of a business establishment located in the area from which an application may originate.

**TO** exercise your right:

1. The undivided co-owner of a building or the co-occupant of a business establishment must be designated, by means of a power of attorney signed by the majority of the people who are co-owners or co-occupants, as the person having the right to sign the register in their name and be entered on the referendum list, if applicable; the power of attorney must have already been produced or be produced at the moment the request is signed;
2. A natural person must be of legal age, a Canadian citizen and not be under curatorship;
3. A legal person/entity must designate from among its members, administrators or employees, by resolution, a person who, on October 1, 2025 and at the time of exercising his/her rights, is of legal age, a Canadian citizen, who is not under curatorship and who is not under any legal disqualification from voting; the resolution must have already been produced or be produced at the moment the request is signed.

Except for a person designated as a representative of a legal person/entity, no one may be considered a qualified voter in more than one capacity, and this, in accordance with article 531 of the *Act respecting elections and referendums in municipalities*.

**LACK OF REQUESTS:**

If the resolution has not been the subject of a valid request, it will not have to be approved by the qualified voters.
