



PUBLIC NOTICE

TO ALL PERSONS ELIGIBLE TO VOTE AND HAVING THE RIGHT TO BE LISTED ON THE REFERENDUM LIST FOR THE ENTIRE TERRITORY OF THE MUNICIPALITY:

Please take notice that during the regular Council meeting held on May 4, 2026, the Council of the Municipality of the Township of Gore adopted **by-law 276 decreeing a loan for the implementation of the Ecolan program for the replacement of septic installations : 2026 and 2027**.

Qualified voters who are entitled to have their name entered on the referendum list may request that **By-law 276** be submitted to a referendum poll by entering their name, address, and elector qualification, together with their signature, in a register open for that purpose.

Any voter presenting themselves to sign the register must first establish their identity by showing their face and by presenting one of the following documents:

- Health insurance card
- Driver's licence
- Canadian passport
- Certificate of Indian Status
- Canadian Forces Identification Card

The number of qualified voters in the Municipality is estimated at **2,371**.

The number of applications required to trigger a referendum on **By-law 276** is **248**. If fewer than 248 applications are received, the by-law will be deemed approved by the qualified voters.

The by-law may be consulted at the municipal office Monday to Thursday, from 9:00 a.m. to 5:00 p.m., and Friday from 9:00 a.m. to 12:00 noon, or on the municipal website at www.cantondegore.qc.ca.

The register will be open from 9:00 a.m. to 7:00 p.m. on Wednesday May 27, 2026, at the municipal office located at 9 Cambria Road, Gore, Québec.

The result of the registration procedure will be announced at 7:05 p.m., or shortly thereafter, on April 21, 2026, at the same location.

REQUIREMENTS TO BE ENTITLED TO HAVE ONE'S NAME ENTERED ON THE REFERENDUM LIST AND TO SIGN THE REGISTER

Any person who, **on May 4, 2026**, meets the following conditions and is not disqualified from voting under section 524 of the Act Respecting Elections and Referendums in Municipalities, and meets the following:

- Is a natural person domiciled in the Municipality of the Township of Gore
- Has been domiciled in Québec for at least 6 months
- Is of legal age
- Is a Canadian citizen
- Is not under curatorship

Any owner of an immovable or occupant of a business establishment who, on **May 4, 2026**, meets the following:

- Has been the owner of an immovable or the sole occupant of a business establishment located within the Municipality of the Township of Gore since at least **May 4, 2026**.
- If a natural person: must be of legal age, a Canadian citizen, and not under curatorship

PUBLIC NOTICE

In the case of undivided co-owners of a building or co-occupants of a business establishment:

- Be an undivided co-owner of the immovable or co-occupant of the business establishment since at least **May 4, 2026**.
- Be designated, by power of attorney signed by the majority of co-owners or co-occupants who are concerned parties and established since at least **May 4, 2026**, as the person entitled to sign the register on their behalf. The power of attorney must be submitted in writing before or during registration

In the case of a legal person:

- Be designated by resolution of its members, directors, or employees
- On **May 4, 2026**, is of legal age, is a Canadian citizen, and is not under curatorship
