- 5. the CDS will act on behalf of its members as a book-entry agent, a bond-holder agent, a payment agent and an agent responsible for transactions conducted for its members, as outlined in the protocol agreement signed between the minister des Affaires municipales du Québec and the CDS;
- 6. the CDS will transfer the funds in accordance with the legal requirements of the bond. For this purpose, the Council authorizes the Secretary-Treasurer to sign the required document under the Canadian banking system entitled "authorization for the pre-authorized debit plan for businesses":
- 7. the CDS will make capital and interest payments to the bond holders by way of electronic transfers of funds and, as such, the CDS will withdraw the required sums directly from the following account:

WHEREAS the Bill favors integrators and therefore encourages an industrial farming model;

WHEREAS the Bill could, in the long term, contribute to the devitalization of farming communities and affect the occupation of Quebec as a whole;

WHEREAS this Bill does not promote the development of agricultural activities, a foundation of economic vitality for the regions of Quebec;

WHEREAS the government of Quebec should adopt policies that favor the occupation of its territory rather than adopt ill-advised reforms that negatively affect the development of its regions.
